DENTAL

Choose from a variety of plans with multiple insurance carriers offered through a Private Health Exchange; **eligible immediately**.

VISION

Choose from a variety of plans with multiple insurance carriers offered through a Private Health Exchange; **eligible immediately**.

DAY CARE FLEXIBLE SPENDING ACCOUNT (DCFSA)

Use pre-tax dollars to pay for out-of-pocket child and elder care expenses (not health expenses).

MEDICAL

After 52 weeks averaging 30 or more hours per week, you can enroll and choose from a variety of plans with multiple insurance carriers offered through a Private Health Exchange.

HEALTH SAVINGS ACCOUNT (HSA)

Use pre-tax dollars to pay for out-of-pocket health care expenses when you are enrolled in a high deductible plan. HSA provides a triple tax advantage!

PAID SICK LEAVE

When you need to care for your own personal illness or injury, or to care for a family member with an illness or injury. Accrue one hour for every 30 hours worked for eligible Team Members.

PAID FAMILY MEDICAL LEAVE (PFML)

Offers up to 2 weeks of paid leave to Team Members, with 1 year of service, who need time to attend qualifying life matters like a serious personal or family health condition or to care for a new child.

SHORT-TERM DISABILITY (STD)

STD coverage provides 60% replacement income for up to 26 weeks of disability, you can choose from 2 plans.

LONG-TERM DISABILITY (LTD)

After 1 year of service averaging 20 or more hours per week, you can enroll in LTD coverage. LTD coverage provides 50% of income replacement after 26 weeks of disability.

LIFE INSURANCE

Choose between 9 coverage amounts: \$10,000; \$15,000, \$20,000, \$50,000, \$100,000, \$150,000, \$200,000, \$250,000, or \$300,000.

SPOUSE/DOMESTIC PARTNER LIFE

Provides up to \$150,000 in coverage for eligible spouse/domestic partner. Spouse/domestic partner amounts are limited to 100% of Team Member coverage amount.

CHILD LIFE

Provides life insurance for your child, up to age 23: \$10,000 or \$20,000.

1st DAY CHOICE MEDICAL

Pays fixed cash benefits for covered medical services, such as doctor visits, hospital stays or prescriptions. *Does not meet ACA mandate for Major Medical insurance.

ACCIDENT INSURANCE

Pays cash in cases of accident injuries such as serious lacerations, burns, sprains, dislocations, and more.

TELADOC PLUS

Teladoc, Behavioral Health Visits, Vision Benefits, Diagnostic and Diabetic Testing Supplies discounts, as well as Discounted Prescriptions bundled together in one convenient benefit.

CRITICAL ILLNESS INSURANCE

Pays a lump sum if you suffer a heart attack, stroke, cancer, and other critical illnesses.

HOSPITAL INDEMNITY

Provides cash benefits associated with a covered hospital stay due to covered sickness including pregnancy or accident.

GROUP LEGAL

Prepaid legal service covers a variety of issues including real estate transactions, will and trust preparation, divorce, bankruptcy, etc.

HOME/AUTO INSURANCE

Discounted insurance for Home and Auto. *Subject to availability. Not available in all states.

IDENTITY THEFT PROTECTION

Safeguard your identity with credit monitoring of all 3 credit bureaus, social media networks, public records, fraud resolution, expense reimbursement, VPN services, etc.

PET INSURANCE

Health insurance for pets.

FEDERAL AND STATE INSURANCE MARKETPLACE

EXTRAS

DARDEN SAVINGS PLAN 401(k)

Upon hire and at least 18 years of age, you can contribute up to 75% of your pay on a before-tax, after-tax or Roth basis.

DARDEN SAVINGS PLAN 401(k) COMPANY MATCH

Darden will match up to 6% of your contributions after 1 year of service and 1,000 hours worked. Must be at least age 18. The plan has a six-year vesting schedule.

EMPLOYEE STOCK PURCHASE PLAN (ESPP)

Take advantage of a 15% discount purchase of Darden (DRI) stock after 1 year of service with 20 hours per week or more worked. You can elect to deduct up to \$5,000 per quarter toward the purchase of Darden stock.
